OF

KLJ RESOURCES LIMITED

(A Public Company Limited by Shares incorporated under the Companies Act, 1956)

The following Memorandum of Association was adopted pursuant to the Special Resolution passed by the shareholders of the Company in their 30th Annual General Meeting held on 30/09/2016, to bring the extent clauses of Memorandum of Association in conformity with Table A of Schedule I to the Companies Act, 2013.

- I. The Name of the Company is KLJ RESOURCES LIMITED
- II. The Registered office of the Company will be situated in the State of West Bengal.
- (a) THE OBJECTS TO BE PURSUED BY THE COMPANY ON ITS INCORPORATION

 ARE:-
- To pool the savings of individual and institutional investors for the purpose of undertaking the business of Portfolio investments in Equity Shares, Debentures, preference shares, Government securities, bank deposits and various other types of investments in India and abroad, and to manage the individual and the institutional funds by acting as custodians and/or investment Managers, by investing these funds from time to time in various forms of investments including real estate & contracts in India and abroad and to initiate and maintain abroad programme of India and abroad.
- 2. To carry on and undertake the business of finance and trading, hire purchase, leasing & to manage lease operations of all kinds, purchasing, selling hiring or letting on hire all kinds of plant and machinery and equipment that the Company may think fit and to assist in financing of all and every kind and description of hire purchase or deferred payment of similar transactions and to subsidies, finance or assist in subsidizing or financing the sale maintenance of any goods, articles, commodities of every kind and description upon any terms whatsoever and to purchase or otherwise deal in forms of immovable or movable properties including land and buildings, plant and machinery, equipment, ship, aircraft, automobiles computers and all consumer, commercial and industrial items and to lease or otherwise deal with them in any leased and new and/or used.
- 3. To carry on all or any of the business of financiers of industrial, commercial and other enterprise and general financiers producers and distributors and exhibitors, money-lenders, sahukars, trustees, real estate owners, land lords, real estate agents, builders, underwriters, guarantors, hire-purchase, dealers, investors, promoters, securities bonds, obligations, claims, license and charges, land, buildings, houses easements, negotiable instruments, decrees, bookdebts, patents, factories mines, industrial undertaking, business concerns, warehouse property

and rights of all kinds, agricultural units shops and go downs, business of insurance agents, trust company, safe deposit company and such other business and acts required in connection therewith, to receive on deposit or borrow and raise money and to lend or deal with the money either with or without interest or security provided the company shall not carry on the business of Banking as defined under the Banking Regulation Act, 1949.

- 4. To carry on the business of an investment Company and for that purpose to invest in, acquire, sell, transfer, subscribe for, hold and otherwise dispose of and invest in any shares, securities, bonds, stocks obligation issued or guaranteed by any Company or Companies constituted and carrying on business in India or elsewhere and debentures, debenture-stock, bonds, obligations and securities issued and guaranteed by any Government, State, Sovereign, Commissioners, Central or provincial public body or authority Supreme, municipal local or otherwise whether in India or elsewhere either out of its own funds or out of funds that it might
- To acquire by concession, grant, purchase, carter, lease, license, or otherwise, with absolutely or conditionally and either alone or jointly with others as contractors or otherwise any land, building, machinery plant works, conveniences and other movable and immovable property of any description, patents, trademarks, concession, privileges and other rights for the objects and business of the company and to construct, maintain and alter any buildings or works necessary or convenient for the purpose of the company and to pay for such lands, buildings, works property or rights or any other property and rights purchased or acquired by or for the company either by shares, debenture, debenture-stock, bonds, or other securities of the company or by cash or otherwise and to manage, develop, sell, let on lease or for hire or otherwise dispose of or turn to account the same at such time or times and in such manner and for such consideration as may be deemed proper or expedient and to reclaim cultive lands and develop the resource thereof by draining, clearing, planting or manufacturing or otherwise.
- 6. To carry on the business of buyer, sellers, suppliers, traders, merchants, importers, exporters, indenters, brokers, agents, assembles, packers stockiest, distributors, financiers, hire purchase and dealers of and in all kinds or agricultural produces, food articles, industrial products industrial components electronic parts and devices, forest products, raw materials, Minerals metals, industrial and other waste and bye products, industrial and other gases, alcohol, edible and non-edible oils and fats, consumer goods, house hold good, hardware and stores plant and machinery stores, Spare parts and accessories, commercial and man-made fibers, textiles or all kinds, readymade garments and any products of cotton and yarn and woolen textiles raw jute and jute products, cement, chemicals, plastics, building materials and vehicles.
- 7. To carry on business of manufacture, fabricators, processors, producers, growers, maker, importers, exporters, buyers, sellers, suppliers, stockiest, agents, merchants, distributors, and concessionaries of and dealers in synthetic rubber, elastomers, synthetic, resins, carbon black rubber latex, plastics, lutexes and formulations thereof including reclaimed rubber, rubber and plastics, resins, compounds and other products, sports goods toys, petrochemicals, Calcium carbide, styrene, butaniene, ethylene, ethyl, alcohol, hydro-carbon, petroleum fration and other synthetic chemicals and chemical substances-basic intermediate or otherwise.

(b) MATTERS WHICH ARE NECESSARY FOR FURTHERANCE OF THE OBJECTS SPECIFIED IN CLAUSE III (a) ARE:-

1. To carry on business as advisers and/or consultants on matters and problems relating to the industries, administration, management, organisation, accountancy, costing, finance, marketing, import, export commercial or economic activities, labour, statistical organization methods, quality control, technical "know-how" operation, manufacture, production, marketing and rendering services like staff and management recruitment, training and placement, to run and conduct bureau for computer services and in particular to develop, design, program me, conduct feasibility studies render services of data processing recruitment training, and placement of

computers personnel including programmes, system analysis to and to acquire, run and/or hire computers for the said business.

- To purchase, acquire, take on lease hire, erect, construct, improve, develop, charge, build letout, exchange, sale, word or deal in land, building, flats, rooms, showrooms, shops, auditoriums, halls markets, sheds, minds factories, mills, plants, farms and do all such acts and things and to purchase, take on lease, acquire, exchange, and to carry on all or any of the business of proprietors, workers, owners, hirers; and supervisors of Manufacturing, works, mills, industrial undertaking and to manufacture, assemble, export, import, and deal in products and connection therewith in which the Company is authorized to carry on its business.
 To take over the whole or any activities.
- 3. To take over the whole or any part of the business, goodwill, trade-marks, properties and liabilities of any person or persons, firm, companies or undertakings either existing or new, possession of any property or rights suitable for the purpose of the Company and to pay for the same either in cash or in shares or partly in cash and partly in shares or otherwise.
- Subject to the Provisions of the Companies Act, 1956/ Companies Act, 2013 as in force from time to time, to amalgamate with any other company of which all or any of their objects having to the objects of the Company in any manner whether with or without the liquidation.
 To apply for and obtain any order with any manner whether with or without the liquidation.
- To apply for and obtain any order under any Act or Legislature, license or authorisation of any objects into effect or for extending any of the powers of the Company to carry on any of its main modification of the constitution of the Company or for any other such purpose which may calculated directly or indirectly to prejudice the interest of the Company.
 To undertake or promote asia titre.
- 6. To undertake or promote scientific research relating to the main business or class of business of the Company.
- To enter into partnership or into any arrangement for sharing profits, union of interest, joint venture, reciprocal concession or co-operation with persons or companies carrying on or engaged in the main business or transaction of the Company.
- To sell, mortgage, exchange, grant licenses and other rights, improve, manage, develop and dispose of undertakings, properties, assets and effects of the company or any part thereof for or other securities of any other such company having main objects altogether or in part similar

- 9. To apply for, obtain, purchase or otherwise and prolong and renew any patents, patent-rights, brevets, inventions, processes, scientific technical or other assistance, manufacturing processes and the like rights or benefits, conferring an exclusive or non-exclusive or limited or unlimited right of use thereof, which may seem capable of being used for or in connection with the main indirectly to benefit the Company or payment of any fee royalty or other consideration and to use, exercise or develop the same under or grant licenses in respect thereof or otherwise deal inventions, right or concessions.
- 10. To establish and maintain or procure the establishment and maintenance of any contributory or non-contributory pension or superannuation, provident or gratuity funds for the benefit of and persons who are or were at any time in the employment or service of the company or any

company which is a subsidiary of the Company or is allied to or associated with the Company or with any such subsidiary company or who are or were at any time Directors or officers of the Company or any other company as aforesaid and the wives, widows, families and dependents of any such persons and also to establish and subsidize and subscribe to any institutions, associations, club or funds calculated to be for the benefit of or advance aforesaid and make payments to any such persons as aforesaid and to do any of the matters aforesaid, either alone or in conjunction with any such other company as aforesaid.

- 11. To sell, let, exchange or otherwise deal with the undertaking of the Company or any part thereof for such consideration as the Company may think, fit and in particular for shares, debentures, or securities of any other company having objects altogether or in part similar to
- 12. To promote any other Company for the purpose of acquiring all or any of the property, assets and liabilities of this Company or for any other purpose which may seem directly or indirectly calculated to benefit this Company.
- 13. To remunerate any person or company for services rendered or to be rendered in or about the formation or promotion of the Company or the conduct of its business or for otherwise assisting or rendering services directly or indirectly to the Company.
- 14. To draw, make, accept, discount, execute and issue bills of exchange, promissory notes bills of lading, warrants, debentures and such other negotiable or transferable instruments, of all ordinary course of the Company.
- 15. To advance money either with or without security, and to such persons and upon such terms and conditions as the Company may deem fit and also to deal with the money of the Company not immediately required.
- 16. To guarantee the performance of contracts by members or persons having dealing with the Company, for the purpose of the Business of the Company.
- 17. To borrow or raise or secure the payment of money in such manner as the company shall think fit and by the issue of debentures charged upon all or any of the company's property stock-in-trade and other movable or immovable, assets and book-debts and claims in action both present and future including its uncalled capital if any and to apply the same or any part thereof for all or any purpose of the Company and to purchase, redeem or pay of any such securities.
- 18. To compensate for loss of office of any Managing Director or Directors or other officers of the Company within the limitations prescribed under the Companies Act or such other statute or rule having the force of law and to make payments to any person whose office of employment or duties may be determined by virtue of any transaction in which the Company is engaged
- 19. To manage land, building and other properties, whether belonging to the company or not and to collect rents and income, and to supply tenants and occupiers and others refreshments, attendance, light, waiting rooms, reading rooms, electric conveniences and other advantages.
- 20. To employ agents or experts to investigate and examine into the conditions, prospects value, character and circumstances of any business concerns and undertakings and generally of any assets properties or rights which the Company propose to acquire.
- 21. To pay for any property or rights acquired by or for any services rendered to the Company and in particular to remunerate any person, firm or company introducing business to the company either in cash or fully or partly-paid up shares with or without preferred or deferred rights in respect of dividend or repayment of capital or otherwise or by any securities which the company has power to issue or by the grant of any rights or options or partly in one mode and partly in another and generally on such terms as the company may determine.

- 22. To send out to foreign countries, its director, employees or any other person or persons for investigation possibilities of main business or trade procuring and buying any machinery or establishing trade and business connections or for promoting the interests of the company and to pay all expenses incurred in the connection.
- 23. To guarantee the Payment of money, unsecured or Payable under or in respect of bonds debentures, contracts, mortgages, charges, obligations and other securities of any company or of any authority Central, State, Municipal, local, otherwise or of any person whomsoever whether incorporated or not and generally to transact all kinds of guarantee business, to guarantee the issue of or the payment of interest on the shares, debentures, debenture-stocks or other securities or obligations of any company or association and to pay or Provide for brokerage, commission and under-writing in respect of any such issue, and to transact all kinds of trust and agency business.
- 24. To open branches sub-offices, depots and multiple shops in any state of India or outside India and to appoint agents stockiest, distributers, sub-distributors and brokers to procure orders, market or sell the products of the company or the goods of any other firm or company in which this company may be dealing in India or abroad.
- 25. To agree to refer to arbitration any dispute, present or future between the Company and any other company, firm, individual or any other body and to submit the same to arbitration in India or abroad either in accordance with Indian or any foreign system of law.
- 26. Subject to the provisions of Companies Act, 2013, to subscribe, contribute, gifts, rights or assets for any national, educational, religious, charitable, scientific, public, general or usual objects or to make gifts or such other assets to any institutions, clubs, societies, associations, trusts, scientific research associations, funds, universities, college or any individual, body of individuals or bodies corporate.
- 27. Subject to the Provisions of Companies Act 2013, to distribute among the members in specie or otherwise any property of the Company or any proceeds of sale or disposal of any property of the Company in the event of winding up.
- 28. To guarantee the payment or performance of any contracts or obligations or become surety for any person, firms or company for any purpose and to act as agent for the collection, receipt or payment of money and to act as agent for and render services to customer and other and to give guarantees and indemnities. To give surety/mortgage/pledge of the property for raising fund/loan for and on behalf of the Company/associates concern/person/any other company.
- 29. To do all or any of above things as principal, agents, contractors, trustees or otherwise and either along or in conjunction with others.
- 30. To do all such other things in any part of the world as may to deem incidental or conductive to the attainment of the above main objects or any of them.
- IV. The Liability of member(s) is limited and this liability is limited to the amount unpaid, if any, on the shares held by them.
- V. "The Authorised share capital of the Company is 25,00,00,000/- (Rupees Twenty Five Crores Only) divided into 2,50,00,000 (Two Crore Fifty Lakhs Only) Equity Shares of Rs. 10/- (Rupees Ten Only) each with power to increase or reduce the capital, to divide the shares in capital for the time being into several classes and attach thereto respectively such preferential, or special rights, privileges or conditions as may be determined by or in accordance with the regulations of the Company and the Companies Act, 2013 and to vary, modify or abrogate such rights, privileges and conditions in such manner as may for the time being be provided by the regulations of the Company".
